





### **EDUCATION FOR FARMERS**

### REGENERATIVE ORGANIC LEARNING CENTER PILOT PROGRAM

In September of 2024 we launched our Regenerative Organic Learning Center (ROLC) pilot program. The ROLC program aims to uplift our farmers as leaders in their communities, to promote regional peer-to-peer conversations, and to offer learning opportunities for neighboring farmers in order to increase the number of Regenerative Organic Certified® farms.

Through the ROLC program, we hope to encourage the next generation of farmers in Regenerative and Organic while learning from local farming communities to understand the issues we face and the solutions to overcome them.

We selected exemplary farms to be in the ROLC pilot based on their demonstrated expertise and leadership in regenerative organic practices. In this first year, we focused on five regions in the United States.



### Growth for Regenerative Organic Certified® Products in the Market

SPINS conducted both a 12 and 52 week trial in Q2 of 2023 and 2024 showing consumer shopping trends and revenue from Regenerative Organic Certified® products. The data collected shows an incredible growth rate in sales for Regenerative Organic Certified® products in natural and multi-outlet grocers. Overall revenue increased by 37% in 2024 when compared to data pulled from the same time period in 2023.

Not only are we seeing a tremendous growth at the check-out counter, but the number of SKUs in the marketplace increased by 71% in 2024 when compared to the same term in 2023, which is clearly indicative of continued growth potential.

By offering Regenerative Organic Certified® products, brands are responding to the consumer desire to have their purchase make a positive impact at every level: environmentally, ethically, and socially.

### IN THE MARKET

### **New Marketing Campaign Launch**

In Q2 of 2024 the Regenerative Organic Alliance formed a Marketing Task Force with our brand partners in order to develop a campaign to help scale consumer demand for Regenerative Organic Certified® products in the marketplace.

Working in tandem with <u>Grit Stdo</u> we developed the new campaign 'Heal the Earth, Nourish your Life' which speaks to consumers through three targeted campaigns for environmental health, social/ human health, and ethical treatment of farmed animals.

The campaign is set to launch in the beginning of Q1 2025, deploying on digital and social platforms along with running advertisements in retailers.



#### **LOOKING AHEAD**



#### **MEASUREMENT, EVALUATION & REPORTS**

There is an increasing need for ROA to be able to deliver quantifiable Data & Reports to support the industry and ROC™ Licensees. Core improvements to the certification database "Intact" are underway with a dedicated and experienced team member to join Q1 of 2025 to support stronger organization of data and the ability to generate reports as well as automate applications and create greater effectiveness and efficiencies.

#### MARKET DEVELOPMENT

The ROA is experiencing tremendous growth. While the primary focus has been based upon food, there are other industry segments that are and can play a vital role in expanding the adoption of ROC™. Leveraging the foundation ROC™ standard, modifications are needed in the application and ROA systems to meet targeted needs, initially for cosmetics, textiles and vineyards.

#### STANDARD REVISIONS

In addition to reviewing the standard for specific guidance and clarification on various crops (see new guidance document for Rice (link here), stakeholder groups will be convened to review the standard for needed updates to provide for variations that may be needed based upon regional differences while holding true to the principles of ROC<sup>TM</sup>.

#### **EDUCATION PROGRAM**

In 2024 we launched our Regenerative Organic Learning center pilot program in hopes of inspiring more farms to transition to regenerative organic practices in their respective bio-region. Due to the great success in 2024, we plan on expanding the Regenerative Organic Learning Center program in 2025. One component of the expansion will be a partnership with Rodale Institute- more details to develop on this partnership and program in quarter 1 of 2025.

#### **LOOKING AHEAD**



### JOURNEY TO REGENERATIVE AND ORGANIC

While the interest in ROC™ is increasing, so is the challenge with transitioning conventional agriculture to Regenerative and Organic Agriculture. To support this need and create the "on-ramp" to regenerative and organic certification we propose three programs for launch and piloting in 2025.

- Expansion of Equivalency programs for all three pillars:
   Soil Health, Animal Welfare and Social Fairness.
- The creation of a transitional program (US Markets) and inconversion (EU Markets) for certification and labeling to support farmers in their journey to ROC™.
- Create a pilot program for Pathway or Step by Step
  Journey to ROC™. This would entail a gap analysis of other
  credible, 3rd Party Certified "Regenerative" programs to
  create a time limited transition out of conventional
  agricultural practices.


